City of Rock Hill Minutes for the Board of Aldermen meeting Tuesday, February 6, 2024 7:00 p.m.

- 1) Mayor Mahan called the meeting to order at 7:00 p.m. and led everyone in the Pledge of Allegiance.
- 2) The Mayor called the roll and the following members of the Aldermanice Board were in attendance: Alderman Jeff Took, Alderman Jennifer Davis, Alderman Ed Johnson, Alderman Robert Weider, Alderman Sabrina Westfall, and Alderman Tina Wiley.
- 3) Citizens to Address the Board: Diane Walters, 1161 Oday. Spoke about the proposed development at 9840 Oakhaven.
- 4) Announcements, Presentations, Proclamations, Communications & Invitations: Mark Spykerman discussed refunding the 2016 GO bonds.
- 5) Minutes of the Previous Meeting January 16, 2024: Alderman Weider moved and Alderman Westfall seconded a motion to approve the minutes for the January 16, 2024 meeting. The minutes were approved unanimously by voice vote.
- 6) Treasurer's Report: Jen Forgy reported:
 - Ms. Forgy asked if there were any questions regarding the warrant. Hearing no questions, Ms. Forgy requested that the Board approve the warrant.
 - Alderman Weider moved and Alderman Westfall seconded a motion to approve the warrant.
 - The warrant was approved unanimously by voice vote.
- 7) Community Development Commission's Report: Garrett Schlett reported that the commission met and discussed the parade at Fall Festival. The Commission recommends that the parade be cancelled due to cost and lack of entries, participants and spectators. Alderman Weider moved and Alderman Davis seconded a motion to eliminate the parade from Fall Festival. The motion was approved by a vote of 5-1. The member of the Aldermanic Board voting against the motion was: Alderman Johnson.

a) Bill No. 2037: AN ORDINANCE AMENDING CHAPTER 150 OF THE ROCK HILL CITY CODE PERTAINING TO THE CLOSURE OF POLICE VIDEO RECORDS.

Alderman Weider moved and Alderman Johnson seconded a motion to approve Bil No. 2037.
